

Chapter 4

MISCELLANEOUS STATUTES AMENDMENT ACT, 2010

(Assented to March 23, 2010)

The Commissioner of Nunavut, by and with the advice and consent of the Legislative Assembly, enacts as follows:

Aboriginal Custom Adoption Recognition Act

1. (1) The *Aboriginal Custom Adoption Recognition Act* is amended by this section.

(2) Each provision listed in Column 1 of Schedule A of this Act is amended by striking out the words set out in the same row of Column 2 and substituting the words set out in the same row of Column 3.

Access to Information and Protection of Privacy Act

2. (1) The *Access to Information and Protection of Privacy Act* is amended by this section.

(2) Each provision listed in Column 1 of Schedule B of this Act is amended by striking out the words set out in the same row of Column 2 and substituting the words set out in the same row of Column 3.

Apprenticeship, Trade and Occupations Certification Act

3. (1) The *Apprenticeship, Trade and Occupations Certification Act* is amended by this section.

(2) Each provision listed in Column 1 of Schedule C of this Act is amended by striking out the words set out in the same row of Column 2 and substituting the words set out in the same row of Column 3.

Arbitration Act

4. (1) The *Arbitration Act* is amended by this section.

(2) Each provision listed in Column 1 of Schedule D of this Act is amended by striking out the words set out in the same row of Column 2 and substituting the words set out in the same row of Column 3.

Area Development Act

5. (1) **The *Area Development Act* is amended by this section.**

(2) **Subsection 2(1) is amended by striking out "the Territories" and substituting "Nunavut".**

(3) **The following provisions are amended by striking out "Commissioner" and substituting "Minister":**

- (a) **subsection 2(1);**
- (b) **subsections 3(1) to (3);**
- (c) **subsection 4(1).**

Business Licence Act

6. (1) **The *Business Licence Act* is amended by this section.**

(2) **Subsection 2(3) is amended by striking out "or regulation".**

(3) **Subsection 4(1) is amended by striking out "The Commissioner or a person authorized by the Commissioner may," and substituting "The Minister may".**

(4) **Subsection 6(1) is amended by striking out "The Commissioner may, by regulation or otherwise," and substituting "The Minister may".**

(5) **The following provisions are amended by striking out "Commissioner" and substituting "Minister":**

- (a) **subsections 4(2) and (3);**
- (b) **subsections 6(1) to (3);**
- (c) **section 9;**
- (d) **section 10.**

(6) **Each provision listed in Column 1 of Schedule E of this Act is amended by striking out the words set out in the same row of Column 2 and substituting the words set out in the same row of Column 3.**

Change of Name Act

7. (1) **The *Change of Name Act* is amended by this section.**

(2) **Section 1 is amended by adding the following definitions in alphabetical order:**

"Clerk" means the Clerk of the Nunavut Court of Justice appointed under the *Judicature Act*; (*greffier*)

"Sheriff" means the Sheriff appointed under the *Judicature Act*; (*shérif*)

(3) Each provision listed in Column 1 of Schedule F of this Act is amended by striking out the words set out in the same row of Column 2 and substituting the words set out in the same row of Column 3.

Child and Family Services Act

8. (1) The *Child and Family Services Act* is amended by this section.

(2) Section 29 is amended by striking out that portion preceding paragraph (a) and substituting the following:

Certified copy of order

29. After an order is made, the Child Protection Worker shall obtain a certified copy of the order from the Clerk of the Nunavut Court of Justice and send it to each of the following persons:

(3) Each provision listed in Column 1 of Schedule G of this Act is amended by striking out the words set out in the same row of Column 2 and substituting the words set out in the same row of Column 3.

Commercial Tenancies Act

9. (1) The *Commercial Tenancies Act* is amended by this section.

(2) Section 1 is amended by

- (a) striking out, in the English version, the period at the end of the definition "mines and minerals" and substituting a semi-colon;**
- and**
- (b) adding the following definitions in alphabetical order:**

"Clerk" means the Clerk of the Nunavut Court of Justice appointed under the *Judicature Act*; (*greffier*)

"judge" means a judge of the Nunavut Court of Justice; (*judge*)

"Sheriff" means the Sheriff appointed under the *Judicature Act*. (*shérif*)

(3) Each provision listed in Column 1 of Schedule H of this Act is amended by striking out the words set out in the same row of Column 2 and substituting the words set out in the same row of Column 3.

Consumer Protection Act

10. (1) The *Consumer Protection Act* is amended by this section.

(2) Section 1 is amended by adding the following definition in alphabetical order:

"Court" means the Nunavut Court of Justice; (*tribunal*)

(3) Each provision listed in Column 1 of Schedule I of this Act is amended by striking out the words set out in the same row of Column 2 and substituting the words set out in the same row of Column 3.

Contributory Negligence Act

11. (1) The *Contributory Negligence Act* is amended by this section.

(2) Section 1 is repealed and the following substituted:

1. In this Act, "judge" means a judge of the Nunavut Court of Justice.

Co-operative Associations Act

12. (1) The *Co-operative Associations Act* is amended by this section.

(2) Each provision listed in Column 1 of Schedule J of this Act is amended by striking out the words set out in the same row of Column 2 and substituting the words set out in the same row of Column 3.

Credit Union Act

13. (1) The *Credit Union Act* is amended by this section.

(2) Each provision listed in Column 1 of Schedule K of this Act is amended by striking out the words set out in the same row of Column 2 and substituting the words set out in the same row of Column 3.

Creditors Relief Act

14. (1) The *Creditors Relief Act* is amended by this section.

(2) Section 1 is amended by

(a) striking out "and includes a deputy Clerk" in the definition "Clerk"; and

- (b) **repealing the definition "Sheriff" and substituting the following:**

"Sheriff" means the Sheriff appointed under the *Judicature Act*; (*shérif*)

(3) Each provision listed in Column 1 of Schedule L of this Act is amended by striking out the words set out in the same row of Column 2 and substituting the words set out in the same row of Column 3.

Defamation Act

15. (1) The *Defamation Act* is amended by this section.

(2) Each provision listed in Column 1 of Schedule M of this Act is amended by striking out the words set out in the same row of Column 2 and substituting the words set out in the same row of Column 3.

Department of Justice Act

16. (1) The *Department of Justice Act* is amended by this section.

(2) Each provision listed in Column 1 of Schedule N of this Act is amended by striking out the words set out in the same row of Column 2 and substituting the words set out in the same row of Column 3.

Devolution of Real Property Act

17. (1) The *Devolution of Real Property Act* is amended by this section.

(2) Section 1 is amended by repealing the definition "Court" and substituting the following:

"Court" means the Nunavut Court of Justice; (*tribunal*)

Economic Development Agreements Act

18. (1) The *Economic Development Agreements Act* is amended by this section.

(2) Section 1 is amended by striking out "the Northwest Territories" and substituting "Nunavut".

Employment Agencies Act

19. (1) The *Employment Agencies Act* is amended by this section.

(2) Paragraph 2(b) is amended by striking out "the Territories" wherever it appears and substituting "Nunavut".

Environmental Protection Act

20. (1) The *Environmental Protection Act* is amended by this section.

(2) Section 1 is amended by

(a) adding the following definition in alphabetical order:

"Controller of Licensing" means the Controller of Licensing appointed under subsection 10.1(1); (*Contrôleur des permis et des licences*)

(b) striking out "and includes the Chief Environmental Protection Officer" in the definition "inspector".

(3) Each provision listed in Column 1 of Schedule O of this Act is amended by striking out the words set out in the same row of Column 2 and substituting the words set out in the same row of Column 3.

Environmental Rights Act

21. (1) The *Environmental Rights Act* is amended by this section.

(2) Each provision listed in Column 1 of Schedule P of this Act is amended by striking out the words set out in the same row of Column 2 and substituting the words set out in the same row of Column 3.

Explosives Use Act

22. (1) The *Explosives Use Act* is amended by this section.

(2) Section 2 is amended by striking out "the Territories" and substituting "Nunavut".

(3) Subsection 5(3) is amended by striking out "the Yukon Territory" and substituting "territory".

Factors Act

23. (1) The *Factors Act* is amended by this section.

(2) The English version of subsection 1(1) is amended by striking out the semi-colon at the end of the definition "security interest" and substituting a period.

Pawnbrokers and Second-hand Dealers Act

24. (1) The *Pawnbrokers and Second-hand Dealers Act* is amended by this section.

(2) The following provisions are amended by striking out "Commissioner" and substituting "Minister":

- (a) subsections 2(1) and (2);**
- (b) subsections 11(1) and (2).**

Perpetuities Act

25. (1) The *Perpetuities Act* is amended by this section.

(2) Each provision listed in Column 1 of Schedule Q of this Act is amended by striking out the words set out in the same row of Column 2 and substituting the words set out in the same row of Column 3.

Pesticide Act

26. (1) The *Pesticide Act* is amended by this section.

(2) Section 7 is amended by striking out "Commissioner" and substituting "Minister".

(3) Each provision listed in Column 1 of Schedule R of this Act is amended by striking out the words set out in the same row of Column 2 and substituting the words set out in the same row of Column 3.

Presumption of Death Act

27. (1) The *Presumption of Death Act* is amended by this section.

(2) Each provision listed in Column 1 of Schedule S of this Act is amended by striking out the words set out in the same row of Column 2 and substituting the words set out in the same row of Column 3.

Public Inquiries Act

28. (1) The *Public Inquiries Act* is amended by this section.

(2) Paragraph 2(a) is amended by striking out "the Territories" and substituting "Nunavut".

(3) The following provisions are amended by striking out "Commissioner" and substituting "Minister":

- (a) section 2;**
- (b) section 3.**

Public Printing Act

29. (1) The *Public Printing Act* is amended by this section.

(2) Each provision listed in Column 1 of Schedule T of this Act is amended by striking out the words set out in the same row of Column 2 and substituting the words set out in the same row of Column 3.

Public Service Garnishee Act

30. (1) The *Public Service Garnishee Act* is amended by this section.

(2) Each provision listed in Column 1 of Schedule U of this Act is amended by striking out the words set out in the same row of Column 2 and substituting the words set out in the same row of Column 3.
