

Chapter 14

MISCELLANEOUS STATUTES AMENDMENT ACT, 2010, No. 2

(Assented to June 10, 2010)

The Commissioner of Nunavut, by and with the advice and consent of the Legislative Assembly, enacts as follows:

Child Day Care Act

1. (1) The *Child Day Care Act* is amended by this section.

(2) Each provision listed in Column 1 of Schedule A of this Act is amended by striking out the words set out in the same row of Column 2 and substituting the words set out in the same row of Column 3.

Condominium Act

2. (1) The *Condominium Act* is amended by this section.

(2) Each provision listed in Column 1 of Schedule B of this Act is amended by striking out the words set out in the same row of Column 2 and substituting the words set out in the same row of Column 3.

Credit Union Act

3. (1) The *Credit Union Act* is amended by this section.

(2) Section 1 is amended by striking out "and includes a Deputy Registrar appointed under section 3" in the definition "Registrar".

Dependants Relief Act

4. (1) The *Dependants Relief Act* is amended by this section.

(2) Section 1 is amended by

(a) repealing paragraphs (b) and (c) of the definition "child" and substituting the following:

(b) a child adopted in accordance with aboriginal customary law, or who appears to the satisfaction of the Court in effect to have been adopted even though there has not been formal compliance with the *Adoption Act*, and

(c) a child of the deceased conceived before and born alive after the date of the death of the deceased; (*enfant*)

(b) repealing the definition "judge" and substituting the following:

"judge" means a judge of the Nunavut Court of Justice; (*judge*)

(c) adding the following definitions in alphabetical order:

"Clerk" means the Clerk of the Nunavut Court of Justice appointed under the *Judicature Act*; (*greffier*)

"Court" means the Nunavut Court of Justice; (*tribunal*)

(3) Section 21 is repealed and the following substituted:

Contribution by transferee

21. On application, the Court may order a transferee of property from the deceased to contribute to the maintenance of one or more dependants of the deceased where all the following criteria are met:

- (a) the estate of a deceased is insufficient to provide appropriate maintenance to the dependants of the deceased;
- (b) the deceased, within three years before the date of his or her death, made a transfer of property that, in the opinion of the Court, was unreasonably large;
- (c) the Court considers it just in the circumstances.

(4) Each provision listed in Column 1 of Schedule C of this Act is amended by striking out the words set out in the same row of Column 2 and substituting the words set out in the same row of Column 3.

Emergency Measures Act

5. (1) The *Emergency Measures Act*, S.Nu. 2007, c.10, is amended by this section.

(2) The English version of section 32 is amended by adding "the" after "each fiscal year if".

Fatal Accidents Act

6. (1) The *Fatal Accidents Act* is amended by this section.

(2) Section 1 is amended by

- (a) repealing the definition "judge" and substituting the following:**

"judge" means a judge of the Nunavut Court of Justice; (*judge*)

(b) adding the following definition in alphabetical order:

"Court" means the Nunavut Court of Justice; (*tribunal*)

(3) Each provision listed in Column 1 of Schedule D of this Act is amended by striking out the words set out in the same row of Column 2 and substituting the words set out in the same row of Column 3.

Film Classification Act

7. (1) The *Film Classification Act* is amended by this section.

(2) Paragraph 7(a) is amended by striking out "the Yukon Territory" and substituting "territory".

Fine Option Act

8. (1) The *Fine Option Act* is amended by this section.

(2) Subsection 2(2) is amended by striking out "the Territories" and substituting "Nunavut".

Insurance Act

9. (1) The *Insurance Act* is amended by this section.

(2) Subsection 1(1) is amended by

- (a) repealing the definition "The Canadian Insurance Exchange";**
- (b) striking out "and includes the Deputy Superintendent of Insurance" in the definition "Superintendent"; and**
- (c) adding the following definitions in alphabetical order:**

"Clerk" means the Clerk of the Nunavut Court of Justice appointed under the *Judicature Act*; (*greffier*)

"Court" means the Nunavut Court of Justice; (*tribunal*)

(3) Paragraph 5(1)(g) is repealed.

(4) Section 69 is amended by repealing the definition "Court".

(5) Subsection 103(4) is repealed and the following substituted:

Exception for group insurance

(4) In the case of a contract of group insurance, insurance money is payable in the province or territory in which the group life insured was resident at the time he or she became insured.

(6) Statutory Condition 2(1)(c) following section 129 is amended by

- (a) in the English version, adding "or territory" after "law of the province"; and**
- (b) in the French version, striking out "de la province où il réside, ou celle du territoire du Yukon, s'il réside dans ce territoire," and substituting "de la province ou du territoire où il réside".**

(7) Statutory Condition 2(2)(a)(ii) following section 129 is amended by

- (a) in the English version, adding "or territory" after "law of the province"; and**
- (b) in the French version, striking out "de la province où elle réside, ou celle du territoire du Yukon, si elle réside dans ce territoire," and substituting "de la province ou du territoire où elle réside".**

(8) Paragraph 145(1)(c) is repealed and the following substituted:

- (c) the insured, by acceptance of the policy, constitutes and appoints the insurer his or her irrevocable attorney to appear and defend in any province or territory in which an action, arising out of the ownership, use or operation of the automobile, is brought against the insured.

(9) Section 167 is amended by repealing the definition "Court".

(10) Subsection 201(2) is repealed and the following substituted:

Exception for group insurance

(2) In the case of a contract of group insurance, insurance money is payable in the province or territory in which the group person insured was resident at the time he or she became insured.

(11) The definition "person" in section 239 is amended by striking out "underwriting member of The Canadian Insurance Exchange,".

(12) The definition "insurance company" in section 244 is amended by striking out "and underwriting members of the Canadian Insurance Exchange".

(13) Each provision listed in Column 1 of Schedule E of this Act is amended by striking out the words set out in the same row of Column 2 and substituting the words set out in the same row of Column 3.

Legal Profession Act

10. (1) The *Legal Profession Act* is amended by this section.

(2) Each provision listed in Column 1 of Schedule F of this Act is amended by striking out the words set out in the same row of Column 2 and substituting the words set out in the same row of Column 3.

Library Act

11. (1) The *Library Act* is amended by this section.

(2) Section 1 is amended by striking out "New."

(3) Section 3 is repealed and the following substituted:

Director

3. The Minister shall appoint a Director of Public Library Services from among the graduates of any library school approved by the Minister.

(4) Each provision listed in Column 1 of Schedule G of this Act is amended by striking out the words set out in the same row of Column 2 and substituting the words set out in the same row of Column 3.

Miscellaneous Statutes Amendment Act, 2005

12. (1) The *Miscellaneous Statutes Amendment Act, 2005*, S.Nu. 2005, c.3, is amended by this section.

(2) Section 8 is repealed.

(3) This section is deemed to have come into force March 22, 2005.

Miscellaneous Statutes Amendment Act, 2009, No. 2

13. (1) The *Miscellaneous Statutes Amendment Act, 2009, No. 2*, S.Nu. 2010, c.3, is amended by this section.

(2) Subsection 15(8) is amended by striking out "March 1" and substituting "April 1".

(3) This section is deemed to have come into force March 23, 2010.

Nunavut Business Credit Corporation Act

14. (1) The *Nunavut Business Credit Corporation Act* is amended by this section.

(2) Each provision listed in Column 1 of Schedule H of this Act is amended by striking out the words set out in the same row of Column 2 and substituting the words set out in the same row of Column 3.

Nunavut Housing Corporation Act

15. (1) The *Nunavut Housing Corporation Act* is amended by this section.

(2) Each provision listed in Column 1 of Schedule I of this Act is amended by striking out the words set out in the same row of Column 2 and substituting the words set out in the same row of Column 3.

Order of Nunavut Act

16. (1) The *Order of Nunavut Act*, S.Nu. 2009, c.13, is amended by this section.

(2) The English version of paragraph 13(2)(c) is amended by striking out "the" after "other functions with".

Pharmacy Act

17. (1) The *Pharmacy Act* is amended by this section.

(2) Section 1 is amended by

- (a) adding "(stupéfiant)" after the English version of the definition "narcotic"; and**
- (b) adding "(infirmière praticienne)" after the English version of the definition "nurse practitioner".**

(3) The English version of paragraph 4(2)(a) is amended by striking out "qualified" and substituting "qualified".

Reciprocal Enforcement of Judgments (Canada-U.K.) Act

18. (1) The *Reciprocal Enforcement of Judgments (Canada-U.K.) Act* is amended by this section.

(2) Each provision listed in Column 1 of Schedule J of this Act is amended by striking out the words set out in the same row of Column 2 and substituting the words set out in the same row of Column 3.
