Chapter 14

SUPPLEMENTARY APPROPRIATION (OPERATIONS AND MAINTENANCE) ACT, NO. 4, 2006-2007

(Assented to November 8, 2007)

Whereas it appears by message from the Commissioner and from the estimates accompanying the message, that the amount set out in the Schedule to this Act is required to defray the operations and maintenance expenses of the Government of Nunavut and for other purposes connected with the Government of Nunavut for the fiscal year ending March 31, 2007;

Therefore, the Commissioner of Nunavut, by and with the advice and consent of the Legislative Assembly, enacts as follows:

Definitions

1. The definitions in section 1 of the *Financial Administration Act* apply to this Act.

Application

2. This Act applies to the fiscal year ending on March 31, 2007.

Supplementary appropriation

3. In addition to the amounts authorized by the Appropriation (Operations and Maintenance) Act, 2006-2007, the Supplementary Appropriation (Operations and Maintenance) Act, No. 1, 2006-2007, the Supplementary Appropriation (Operations and Maintenance) Act, No. 2, 2006-2007 and the Supplementary Appropriation (Operations and Maintenance) Act, No. 3, 2006-2007, there may be expended from the Consolidated Revenue Fund, in accordance with the Financial Administration Act, the amount set out as a supplementary appropriation for the item in the Schedule.

Purpose of appropriation

4. The amount set out as a supplementary appropriation for the item in the Schedule may be expended only for the purpose of defraying the operations and maintenance expenses of the Government of Nunavut and for other purposes connected with the Government of Nunavut, in accordance with the Schedule.

Lapse of appropriation

5. Subject to sections 36 and 37 of the *Financial Administration Act*, the authority in this Act to make expenditures for the purposes and in the amount set out in the Schedule expires on March 31, 2007.

Accounting

6. Amounts expended under the authority of this Act shall be accounted for in the Public Accounts in accordance with sections 72 and 73 of the *Financial Administration Act*.

Commencement

7. This Act shall be deemed to have come into force on April 1, 2006.
