They also include the laws of the Northwest Territories as duplicated by section 29 of the *Nunavut Act* (Canada) and laws made by the Legislature for the Northwest Territories pursuant to section 76.05 of the *Nunavut Act* (Canada).
3. References to statutes made before April 1, 1999 are references to the statutes made by the Legislature of the Northwest Territories. References to statutes made on or after April 1, 1999 are references to the statutes made by the Legislature of Nunavut.
4. The authoritative text of statutes made before April 1, 1999 can be ascertained from the *Revised Statutes of the Northwest Territories, 1988* and the Annual Volumes of the Statutes of the Northwest Territories. The Tables accompanying those volumes may be consulted for assistance.
