PROPERTY ASSESSMENT REGULATIONS, amendment

The Minister, under section 117 of the *Property Assessment and Taxation Act* and every enabling power, makes the annexed amendments to the *Property Assessment Regulations*.

- 1. These regulations amend the *Property Assessment Regulations*.
- 2. The following is added after section 1.1:
- 1.2 The following annual multipliers for 2025 and any subsequent year must be published by notice in the *Nunavut Gazette*:
 - (a) base year modifiers;
 - (b) cost index factors otherwise provided under section 1.190.050 of Schedule 1.
- 3. Subsection 1.180.010(2) of Schedule 1 is amended by replacing "sections 1.180.011 and 1.180.015" with "sections 1.180.011 to 1.180.015".
- **4. Section 1.180.011 of Schedule 1 is amended by adding** "or published in the *Nunavut Gazette* in accordance with section 1.2 of the regulations" **after** "listed in section 1.180.050".
- 5. The following is added after section 1.180.011 of Schedule 1:
- 1.180.012 The appropriate improvement factor for 2025 and any subsequent base year is the improvement factor for that year published in the *Nunavut Gazette* in accordance with section 1.2 of the regulations.
- 6. Section 1.180.015 of Schedule 1 is repealed and replaced by
- 1.180.015 The appropriate improvement factor for a year that does not appear in section 1.180.050 and for which no improvement factor is published in the *Nunavut Gazette* in accordance with section 1.2 of the regulations is equivalent to the appropriate improvement factor for the previous year.
- 7. Section 1.190.020 of Schedule 1 is amended by replacing "1.190.025" with "1.190.021 and 1.190.025".
- 8. The following is added after section 1.190.020 of Schedule 1:
- 1.190.021 The appropriate index factor for 2025 and any subsequent year is the cost index factor for that year published in the *Nunavut Gazette* in accordance with section 1.2 of the regulations.

9. Section 1.190.025 of Schedule 1 is repealed and replaced by

- 1.190.025 The appropriate index factor for a year that does not appear in section 1.190.050 and for which no index factor is published in the *Nunavut Gazette* in accordance with section 1.2 of the regulations is equivalent to the appropriate index factor for the previous year.
- 10. (1) The following provisions of the French version are amended by replacing "l'article", wherever it appears, with "la section":

 - (f) subsection 14(2);
 - (g) Schedule 7;
 - (h) Schedule 8.
