LOTTERIES REGULATIONS, amendment

The Commissioner in Executive Council, under section 4 of the *Lotteries Act* and every enabling power, makes the annexed amendments to the *Lotteries Regulations*.

1. These regulations amend the *Lotteries Regulations*.

2. Subsection 1(1) is amended

- (a) in the English version by replacing the period at the end of the definition of "nevada ticket" with a semi-colon; and**
- (b) by adding the following definitions in alphabetical order:**

"Chase the Ace raffle" means a progressive, multiple draw raffle in which the winner of each draw wins

- (a) an event prize, corresponding to a percentage of the gross proceeds of tickets sold for that draw, and
- (b) the right to have a card pulled from a deck of cards, following which
 - (i) if the pulled card is the target card, the winner of the draw wins the progressive jackpot, corresponding to a percentage of the gross proceeds of the entire raffle, or
 - (ii) if the pulled card is not the target card, the winner of the draw does not win the progressive jackpot and the pulled card is removed from the deck for all subsequent card pulls in that raffle; (*tombola de type chasse à l'as*)

"raffle" means

- (a) a single draw raffle,
- (b) a multiple draw raffle other than a progressive raffle, or
- (c) a Chase the Ace raffle. (*tombola*)

3. (1) The French version of subsection 5(2) is amended by replacing "proposée" with "projetée".

(2) The following is added after subsection 5(2):

(3) An application for a lottery licence must be accompanied by the applicable fee set out in Schedule 2.

4. Subsection 9(3) and paragraph 9(4)(a) are amended by replacing "the Schedule" with "Schedule 1".

5. (1) Section 11 is renumbered as subsection 11(1).

(2) The following is added after subsection 11(1):

(2) A request to amend a lottery licence must be accompanied by the fee set out in Schedule 2.

6. (1) The French version of subsection 66(2) is amended by replacing "licence de tirage" with "licence de tombola".

(2) The following is added after subsection 66(3):

(4) A licence to conduct a Chase the Ace raffle expires on the earlier of

- (a) the date on which the target card is pulled; and
- (b) the expiry date endorsed on the licence.

7. Section 64 is amended by

(a) repealing and replacing paragraphs (e) and (f) with:

- (e) in the case of a Chase the Ace raffle,
 - (i) the value of the event prize for each draw, expressed as a percentage of the gross proceeds of tickets sold for that draw,
 - (ii) the value of the progressive jackpot, expressed as a percentage of the gross proceeds of the entire raffle,
 - (iii) the number of cards in the deck of cards at the beginning of the raffle, and
 - (iv) the identity of the target card;
 - (f) in the case of a raffle other than a Chase the Ace raffle,
 - (i) the number and value of the prizes to be awarded, and
 - (ii) if merchandise prizes or donated prizes are to be awarded, the value of the merchandise or donated prizes;
- (b) in paragraph (g) by adding "per raffle or per draw" after "to be printed".**

8. The French version of subsection 67(2) is amended by replacing "du tirage" with "de la tombola".

9. Section 69 is amended

- (a) in paragraph (b) by adding "to which the ticket relates" after "the draw or draws";**
- (b) by repealing and replacing paragraphs (d) and (e) with:**
 - (d) in the case of a Chase the Ace raffle,
 - (i) the value of the event prize for the draw, expressed as a percentage of the gross proceeds of tickets sold for that draw,

- (ii) the value of the progressive jackpot, expressed as a percentage of the gross proceeds of the entire raffle,
- (iii) the number of cards in the deck of cards at the beginning of the raffle, and
- (iv) the identity of the target card;
- (d.1) in the case of a raffle other than a Chase the Ace raffle, the prizes to be awarded;
- (e) the maximum number of tickets printed for the draw or draws to which the ticket relates;

10. The French version of section 73 is repealed and replaced by:

73. Par dérogation à l'alinéa 9(1)i), les personnes qui aident à la tenue de la tombola peuvent acheter des billets des autres membres de l'organisme religieux ou de charité qui parraine la tombola.

11. Section 74 is amended

- (a) **by repealing and replacing paragraph (d) with:**
 - (d) in the case of a Chase the Ace raffle,
 - (i) the value of the event prize for each draw, expressed as a percentage of the gross proceeds of tickets sold for that draw,
 - (ii) the value of the progressive jackpot, expressed as a percentage of the gross proceeds of the entire raffle,
 - (iii) the number of cards in the deck of cards at the beginning of the raffle, and
 - (iv) the identity of the target card;
 - (d.1) in the case of a raffle other than a Chase the Ace raffle, the prizes to be awarded;
- (b) **in paragraph (e) by adding "per raffle or per draw" after "printed"; and**
- (c) **in the French version of paragraph (f) by replacing "lesquelles le tirage est tenu" with "lesquelles la tombola est tenue".**

12. The Schedule is renamed as Schedule 1.

13. Schedule 2 set out in the Appendix to these regulations is added after Schedule 1.

14. The *Lottery Licences Fees Regulations*, R.R.N.W.T. 1990,c.10(Supp.), are repealed.

15. These regulations come into force 14 days after the day they are registered by the Chief Legislative Counsel under the *Legislation Act*.
